

**ELECTION REGULATIONS AND GUIDELINES – 2019/2020**

1. No candidate shall be allowed to display his/her poster before he/she is officially nominated.
2. No candidate shall campaign before he/she is officially nominated.
3. No candidate shall be allowed to put posters on walls of any building, gates, monuments, signposts and official notice boards.
4. Candidates may not be nominated unless they have removed their posters from the above.
5. No candidate should remove/deface any candidate's poster.
6. Bribing or inducing of voters by any candidate or anybody is prohibited.
7. Any Electoral malpractice may lead to disciplinary action and or disqualification.
8. Use of abusive or vulgar language or defamation shall lead to disciplinary action or disqualification or payment of fines.
9. Intimidation of voters or use of threats by candidates or any hired person shall lead to disciplinary action, disqualification or payment of fines.
10. No candidate shall be allowed in halls of residence for campaigns beyond 10:00pm.
11. No candidate shall be allowed in lecture rooms unless permitted by the lecturer and/or the class.
12. No campaign shall go beyond twelve (12) hours to Election Day.
13. Each candidate shall be allowed a maximum of only two (2) cars during the campaign period.
14. Cars used for campaigns should not be under Dangerous Mechanical Conditions and should receive clearance from the security office before accessing the University gates.
15. No campaign activities shall be allowed within a radius of 50 meters from the main administration block, breach of which shall lead to disciplinary actions and or disqualification and or payment fines.

16. The maximum speed limit on all University roads shall be 5km per hour during the campaign period.
17. Disruption or interruption of general University activities through noise shall lead to disciplinary actions, fines or disqualification.
18. Any other rule as per the guild constitution and University Rules and Regulations shall be applied by the Electoral Commission.
19. Any candidate found guilty of physical assault, intimidation or anything that interferes with the security and safety of EC Executive and commissioners, or polling assistants shall be immediately disqualified.
20. Candidates who come thirty (30) minutes late to any Electoral engagement will not participate but instead join the audience.
21. Materials including alcoholic drinks, campaign T-shirts, whistles, vuvuzelas, music systems, posters, and related identities that give attachment to any political camp shall not be permitted around any Electoral venues.
22. Jackets, sweaters, long sleeved shirts, bags, envelopes and any suspicious electoral fraud material shall not be allowed near the polling station.
23. Motorized Public Address System on campus shall be limited to only official Electoral Commission rally days and away from the lecture rooms and offices.
24. Teacher's road, the road leading to the Administration Building from the West End pitch down to Medical Centre and the entire area around the entire main Administration Building shall be out of bounds from campaign activities for the entire period. A candidate found in breach of this guidelines shall be qualified from the race.
25. Motorcades for campaigns are only allowed to use fisher road to west end pitch and out of the University.
26. Motorcades for campaigns shall be allowed around University only after 5:00pm save for activities on the electoral roadmap as communicated by the EC.

**NOTE:**

The electoral commission shall reserve the rights to amend the above and issue penalties in case the above rules are not followed. The penalties shall range from disciplinary action, Disqualification, to fines that shall be paid to the Guild account.
